Release Waiver

All cyclists MUST wear a helmet!

In consideration of being permitted to participate in any way in the SMECO 75 Bike Ride, I, for myself or assigned heir, representative, or next of kin:

- Acknowledge, agree and represent that I understand the nature of the activity and am qualified to participate. I agree to obey all state and local traffic laws and regulations and understand that if I leave the designated route(s), I am no longer considered to be on the SMECO 75 Bike Ride.
- Acknowledge that the Bike Ride will be conducted over public roads and facilities open to the public and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Bike Ride.
- Fully understand that the activity involves risk and dangers of serious bodily injury; these risk and dangers may be caused by my own actions, or inactions, the action or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the releasees named below; there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time and I fully accept and assume all risks and all responsibility for losses, cost, and damages I incur as a result of my participation or that of the minor that I have signed for in the activity.
- Hereby release, discharge, and covenant not to sue SMECO, their administrators, directors, agents, officers, members, volunteers, employees, other participants, any sponsors, advertisers and, if applicable, owners and lessors of premises on which the activity takes place (each considered one of the "releasees" herein), from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise, including negligent rescue operation; and I further agree that if, despite the release and waiver of liability, assumption of risk and indemnity agreement, I or anyone on my behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any litigation expense, attorney fees, loss, liability, damage, or cost that may incur as the result of any such claim.

I will wear a certified helmet when riding my bicycle on a club ride or event.
